

CITY OF RAPID CITY WATER RECLAMATION FACILITY SOUTH PLANT IMPROVEMENTS

AUGUST 2025



The Rapid City Water Reclamation Facility (WRF) is currently undergoing major upgrades to create a more efficient, lower-maintenance, and highly reliable water reclamation system that will serve our community for years to come. This vital \$204.2 million project is fully funded through an SRF loan, the City's enterprise fund, and \$52.8 million in American Rescue Plan Act (ARPA) grant funding. Since our last update, the project has made significant progress and we're on track for completion in winter 2028.

June 2025: The concrete crew placed approximately 880 cubic yards (or 88 trucks worth) of concrete for the floor of the Secondary Clarifier #4. The secondary clarifiers settle suspended solids in the wastewater treatment process and are part of the final step before disinfection of the water.



July 2025: The Dewatering Building precast panels have been erected. The Dewatering Building processes sludge from the Solids Holding Tank and is on track for completion in 2027.



June 2025: Four screw presses were installed into the Dewatering Building. Screw presses separate solids from the liquid that comes from the Solids Holding Tank for disposal. The remaining liquids are recycled back into the treatment process.
